# 20/89. Actions

**HB** recapped previous actions and updates:

20/79.1 Village Car Parking. It has been noted on several occasions that some parking in the village constitutes a hazard. In particular in the vicinity of the railway bridge. Although currently there are no enforceable parking restrictions, all village residents are asked to be mindful of creating dangerous conditions when parking. Eg. Parking in such a way that traffic is forced onto the wrong

side of the road or creating blind spots for other road users – particularly on blind corners in the area near the railway bridge. The Parish Council will also consult with various authorities to review options for enforcing safe and considerate parking. **FN/MP** 

20/79.2 Lights near the Rail Bridge. It was discussed and agreed that these fall within the responsibility of the Highways department. It was resolved that FN/MP raise this issue with Highways. Action – Tactful request for careful parking of larger vehicles on blind bends, requesting villagers be aware of parking in potential hot spots

#### 20/90 Witham Water

Ben Newby & Tim St John from Bristol Water came to update WFPC on the ongoing situation.

Four options initially possible, a full survey will be required and as soon as the WFPC has Bristol Waters full report. A village meeting will be held in due course.
